**CERTIFICATE OF INCORPORATION  
OF  
SAVE THE AMERICAN FAMILY, INC.**

Under Section 402 of the Not-for-Profit Corporation Law

- FIRST:** The name of the corporation is:
- SAVE THE AMERICAN FAMILY, INC.**
- SECOND:** This corporation is a corporation as defined in subparagraph (a)(5) of Section 102 (Definitions) of the Not-for-Profit Corporation Law.
- THIRD:** The purpose or purposes for which the corporation is formed are as follows:
- (a) To promote knowledge and teach successful life skills to American families;
  - (b) To develop and implement strategies to promote such skills;
  - (c) To conduct scientific research and develop educational materials in connection with the development of such strategies;
  - (d) To give counseling, advice, support, guidance and seminars, to publish programs, books and other materials, and to promote specifically the following areas and topics of life skills:
    - (1) Premarital, marital, and postmarital relations;
    - (2) Child raising and the promotion of responsible attitudes to secure the mentally and physically healthy development of children;
    - (3) Relationships;
    - (4) Marital and family happiness, effective communication, and related skills;
    - (5) Divorce prevention and promotion of scientific knowledge that divorces (i) are unnecessary in the case of marriages undertaken in the traditional manner, (ii) increase the risk of disease and cause shorter life spans for both parents, and (iii) cause multiple life-destroying disasters for

children raised in one-parent or stepparent families, especially damaging if the biological father is missing, including (a) a 5-fold risk of suicide, (b) a 10-fold risk of alcohol and drug abuse, (c) a 14-fold risk of committing rape, (d) a 20-fold risk of incarceration as a result of the commission of serious crimes, and (e) a 32-fold risk of running away from home;

(6) In the case of divorce plans, to promote knowledge and provide assistance with obtaining legal help to secure equal rights for both partners, husband and wife, to provide hands-on help, and to promote scientific knowledge for the couple to be happily reunited, which would be especially life-saving for children of such couples.

(7) To promote recognition regarding mental and physical health, suicide prevention, exercise and physical activity, weight management (over 65% of the American population is overweight, and over 35% are obese, both of which cause most preventable diseases such as cancer, heart disease, high blood pressure, diabetes, etc., thus overburdening the social security and health care systems nationwide), with the principle that prevention is best, to promote arts and music for their health-related benefits, and to promote the overall importance of proper lifestyle habits for a healthy, satisfying and happy life;

(8) To promote knowledge and provide guidance in wealth building and other issues related to successful life;

(9) To promote knowledge of spiritual and religious issues related to a happy, healthy, and rewarding life, and to give competent Biblical, Christian, and other denominational counseling; and

(10) To promote global thinking and positive attitudes to better understand ourselves, our world, its needs, its different cultures, and its past and future;

(e) To promote the prevention of child abuse in any form, and the prevention of mental and physical domestic violence in an unbiased manner while helping the public, courts, lawmakers, law enforcement, and other officials become aware of the widespread American myth that only men are irresponsible or violent; the facts are that over 65% of child abuse and over 45% of domestic violence is committed by women.

(f) To provide referrals to licensed, certified and experienced professionals, including educators, psychologists, lawyers, social workers, health professionals, and other professionals.

(g) To inform lawmakers, federal and local government officials, the courts, and other related institutions and individuals to recognize the real, scientific facts in any or all these areas, topics and situations, and to promote these facts and knowledge to the American public and worldwide. The promoted use of this new knowledge will produce enormous savings and economic benefits to individuals and the American nation as a whole, in addition to easing human suffering and/or causing such suffering to fully disappear in these areas of life.

(h) To establish affiliate organizations nationwide.

(i) To purchase and sell property, both real and personal, and mortgage and lease such property as may be necessary for the conduct and welfare of the corporation; and

(j) To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, or officers except as permitted under Article 5 of the Not-For-Profit Corporation Law.

FOURTH: The public will benefit from the above-stated purposes by (1) reducing the amount of government assistance required for public health costs, welfare expenditures, and social security costs, (2) reducing the burden on the court system, and (3) reducing the crime rate.

FIFTH: The corporation shall be a Type C Corporation pursuant to Section 201 of the Not-for-Profit Corporation Law.

SIXTH: The office of the corporation is to be located in the County of New York, State of New York.
